Prize will be distributed in equal proportion if in case there are more than one awardee.

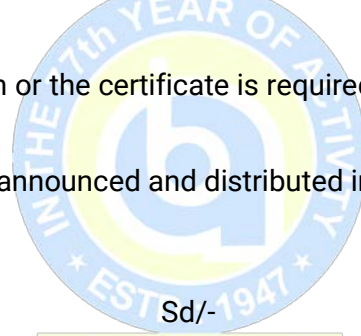
